Named President, World Development Foundation

Ambassador and Former Permanent Representative to the United Nations joins WDF, October 2017

Ambassador Mac Donald was born in Suriname and received his legal education at the Law Faculty of the Anton de Kom University in Paramaribo, (1994) and at the American University in Washington DC, where he obtained an additional Masters of Law in "Law and Government" at the Washington College of Law (2003). He acquired Post-Doctoral honors from the United Nations Institute for Training and Research (UNITAR), the International Labor Organization (ILO), the Universities of Utrecht and Amsterdam in the Netherlands, and the Catholic University of Leuven in Belgium.

Dr. Henry Mac Donald received an Honorary Degree in Doctorate for Philosophy in Humanities and the Golden Rule International Award for his international work on gender equality and women's empowerment at the United Nations.

Ambassador Mac Donald has been a guest Professor at various Universities and Colleges in the United States and is one of the few scholars who publishes frequently in English in the Surinamese Law Journal.



Ambassador MacDonald was a senior legal advisor on human rights topics and a principal speech writer for his Government on development, legal and diplomatic matters. He represented Suriname as its Principal Expert before all Human Rights Treaty Bodies at the United Nations (e.g. the Universal Periodic Review (2011); the UN Committee **Regarding the Elimination of Racial** Discrimination (2009 and 2015); the UN Committee for the Rights of the Child (2007); the UN Committee against the Discrimination of Women (2002), and at the Organization of American States such as at the Moiwana hearings before the Inter American Commission on Human Rights (2003) and the Inter American Court of Justice in 2004.

His Excellency Ambassador Dr. Henry Mac Donald Named President, World Development Foundation



Since his first arrival at the United Nations ten years ago, he served on several occasions as Chairperson of the CARICOM Caucus of Ambassadors to the United Nations and as Chair of the GRULAC Regional Grouping.

He was a Vice President of the 65th General Assembly, in which capacity he served on numerous occasions as Acting President.

He was also very instrumental in having the two only Surinamese Human Rights Experts being elected in respectively the Human Rights Committee (2010 & 2014) and the ECOSOC Committee on Economic, Social and Cultural Rights (2012).

He was the Chairperson of the Social, Humanitarian and Cultural Committee, generally referred to as the Third Committee for the 67th Session of the United Nations General Assembly.

On November, 2012, he orchestrated a unique combined Second and Third Committee Event on Communication for Development at the UN.

Ambassador Mac Donald has been a leading force for gender equality, as an early member and proponent of the HEFORSHE movement, begun by Ms. Emma Watson. He also pioneered the Barber Shop Conferences at the Unite Nations, furthering the work of UN WOMEN at Headquarters.

Prior to being named President, Dr. Mac Donald moderated the 23 May Conference at the United Nations endorsing public-private partnerships as a common-sense approach to involving all stakeholders in the realization of the Sustainable Development Goals.

Government officials, corporate leaders, NGOs and investors from around the world gathered at the United Nations on 23 May 2017 to engage in a focused dialogue on Public-Private Partnerships (PPP): Member State Initiatives to Ensure the Success of the Sustainable Development Goals (SDGs) hosted by the Permanent Mission of Suriname, in cooperation with the World Development Foundation. "Good, far-reaching policies earning sincere endorsement, will not grow nor endure without private investment" said Henry Mac Donald, Permanent Representative of Suriname to the United Nations, to open the conference. Ambassador Mac Donald went on to further explain that private sector investors have been successfully able to obtain financial returns on their bottom lines while at the same time benefiting the bottom half of the world as they struggle for sustainability.

The session was inaugurated by the President of the General Assembly, Peter Thomson, followed by an in depth speech on the topic by the Principal Representative of the United Nations Development Program (UNDP) for the Caribbean and Latin America.

The morning panel sessions underscored the importance of the United Nations, in its role as a global convener and catalyzer of people, to serve as a platform to bring the private and public sectors together in an effort to harness the power of all stakeholders. A highlight of the morning included a candid discussion between Michel Martelly, former President of Haiti, and Amir Dossal, Founder and President of the Global Partnerships Forum. President Martelly emphasized that poverty serves as the ultimate obstruction to development and it is outside investment, through public-private partnerships, that can serve as the first link in the chain to improving lives.

In the afternoon panel sessions Ambassador Mac Donald along with His Excellency Rudolph Michael Ten-Pow, Permanent Representative of Guyana to the United Nations, unveiled a new sustainable eco-tourism plan for the Caribbean Guyana Shield Area in recognition of the UN International Year of Sustainable Tourism for Development 2017. Ambassador Ten-Pow, quoting a sentiment made earlier by Mr. Dossal, stressed that it was time "to start doing what we need to do" and encouraged countries to create bankable projects that will be able to attract the investment sector. In a later panel corporate leaders echoed this same notion and instructed both sectors to focus on their own core competences, while also recognizing that a shared mission is not necessary so long as the goals remain complementary.

Since the private sector accounts for roughly 90% of jobs globally, public-private partnerships will be integral to implanting and verifying the success of the U.N. 2030 Agenda. In line with SDG 17 (the Revitalization of Global Partnerships), private industry and civil society will need to share the responsibility of building new economies. The public and private sectors, along with governments, must come together to set standards and goals in order to drive this global initiative.

French Guyana, Suriname, and Guyana form a trio destination most travelers have never seen or known. Through public private partnerships coming this year, expect this to change.


This session was a main focus of the conference. The panel provided an early introduction to an initiative which will require private investment, local management and ownership – the Guyana Shield Area for eco-tourism will now begin planning that is sustainable on all levels, benefits local communities and the general development efforts of all three nations, while delivering support for the Sustainable Development Goals.

The project is being developed during an important and related "Year" for the UN World Tourism Organization. The Guyana Shield hopes to emulate the best and most important aspects of the UN WTO International Year of Sustainable Tourism for Development, 2017 goals throughout its development, marketing, and implementation.

Next steps include a public statement of cooperation among all parties, introducing the services and beauty abounding within the Shield areas of Guyana, Suriname, and French Guyana – and joining with private partners to release and market this new tourism product to the world. The World Development Foundation has agreed to assist in supporting these initial efforts throughout 2017.



The Guyana Shield Area



The **Guiana Shield** is one of the three cratons of the South American Plate. It is a 1.7 billionyear-old Precambrian geological formation in northeast South America that forms a portion of its northern coast. The higher elevations on the shield are called the Guiana Highlands, which is where the table-like mountains called tepuis are found. The Guiana Highlands are also the source of some of the world's most spectacular waterfalls such as Angel Falls, Kaieteur Falls and Kuquenan Falls.

The Guiana Shield underlies Guyana (previously British Guiana), Suriname (previously Dutch Guiana) and French Guiana (or Guyane), as well as parts of Venezuela, Colombia, and Brazil.

The Guiana Shield is one of the regions of highest biodiversity in the world, and has many endemic species. The region has over 3000 vertebrate species: 1168 fresh water fish, 269 amphibians (54% endemics), 295 reptiles (29%), 1004 birds (7.7%), and 282 mammals (11%). Plant life is equally rich and 13,367 species of vascular plants have been found, approximately 40% of which is considered endemic.

The shield is overlain by the largest expanse of undisturbed tropical rain forest in the world. Guianan rain forest is similar in nature to Amazonian rain forest and known protected areas include the Iwokrama Forest of central Guyana, Kaieteur, Kanuku National Park of southern Guyana, the UNESCO World Heritage Site Central Suriname Nature Reserve of Suriname, and the Guiana Amazonian Park in French Guyana. - Wikipedia 2017

Originally titled the **2016 NGO Summit for the SDGs,** the Lead Endorser, Permanent Mission of Ghana to the United Nations, altered the title slightly, keeping much of the original programming intact. The final title used for the gathering was:

Public Private Partnerships for the Success of the Sustainable Development Goals

Recognizing the Success & Finding NGO Consensus to Move Forward After The UN DPI 66th Annual NGO Conference "Education for Global Citizenship: Achieving the Sustainable Development Goals Together" 24, 25, and 26 August 2016

This informative session was free and registration was open to all. It was presented with the endorsement of the Permanent Missions of Ghana to the United Nations. **Bruce Knotts,** Chair of the NGO DPI Executive Committee led the three-day proceedings as Conference Chair, held in Conference Room #1 on the UN campus in New York City. **Patrick Sciarratta** developed the program with the sole support of the World Development Foundation, **Dr. William Guo** and **Cristina Fan**, directors.

• The aim of this event was to continue discussions on NGO responsibilities for SDG implementation, reporting, and verification as a full partner in the UNs 2030 global challenge for development. What actual programming and partnerships will fulfill the challenges presented by the UN SDGs, the outcome documents, and other discussions concluded at the recent UN DPI Conference last May in the Republic of Korea? What other Public Private partnerships were possible that would help ensure SDG success?

• This three-day event enabled NGOs, the media, and others who were not able to attend the successful gathering in Korea, as well as prepare all those in civil society to answer the challenges and opportunities posed by the SDGs and provide input on future steps. The gathering reflected other efforts to move public and private partnerships, alongside UN efforts, to ensure maximum success for the SDGs over the coming 15 years.

• Historically, civil society may have had less of a role in planning the global development agenda. This summit empowered civil society to collaborate in a way that may in some ways shape the SDGs for years to come. The UNs 2030 Challenge has determined that an urgent call must reach from **Member States, the UN global staff, to civil society, all working together** on the roadmaps for SDG success.

The Sessions was opened by Conference Chair **Bruce Knotts**, with additional welcomes from the President of the UN General Assembly, **H.E. Mogens Lykketoft**, followed by official UN welcomes from **H.E. Ambassador Oh Joon**, Permanent Mission of Republic of Korea to the United Nations, offering the Host Nation Welcome from the 66th Annual UN DPI Conference last Spring, followed by **H.E. Ambassador Marc-André Blanchard**, Permanent Mission of Canada to the United Nations, a long time supporter of civil society as an active participant in SDG success.

A highpoint of the Opening featured artist **Jakob Trollback**, the creator of the SDG visual element, who reminded us that communicating the goals in all ways was essential to people understanding and accepting them as their own.

Other welcomes were provided by representatives of the mayor of New York City, Helen Clark of UNDP, as well as **Jeffrey Bre**z and **Bruce Knotts**, representing UN DPI and NGO DPI, who helped lead the initial conference on the topic in the Republic of Korea at the 66th Annual DPI Conference on May 31, June 1 and 2, 2016.

Part of the mission of this event was to spur on public private partnerships in the civil society sector, in order to help promote SDG success across all sectors. The events began with a recap of recent past efforts, from the Korea DPI conference to the present. Titled: Coming from, Going to: Starting at the Outcome, Where Next? was moderated by a former DPI Conference Chair, **Jeffery Huffines** and featured the reflections of **Ms. Diana Bas** (Executive Director, UNDP), and **Scott Carlin**, DPI Conference Co-Chair, Korea. ADDENDUM 1 – Notes From A Panel

Round Table 3 - moderated by Mr. Amir Dossal

Amir Dossal: Our panel will be slightly different. If you will agree, we all know the problem, and dare I say - we also know the solutions. I apologize that we have an unbalanced agenda which we will correct soon. Let's start, and after each of the panel members will introduce their work we will move on to questions from the audience.

Bryan Maygers, Executive Blog Editor at the Huffington Post: Typically, journalists are cynical. They don't report on good news but on what's broken. we decided it's not the best way to look at things. We are mission driven, and we want to empower people to make the world a better place, but we also decided it's good for business: We focus on what's working. We live in a world where people spend a lot of time Online, and people increasingly define themselves by what they share Online. People don't want their image Online to be overly negative all the time, so good news and facebook equal lots and lots of shares. Therefore, we focus on positive videos about fixing and improving the world. These stories receive incredible engagements from readers around the world. we are now also trying to see how we will have those videos connect people to taking a specific action in support of the particular issue.

Dan Connors of Aris Wind and Jim Smith of Airsynergy: Electrification of the developing world is still a vision, and there's a lot to be done. we have tangible progress, yet 1.3 billion people still don't have access to electricity.

The two companies create wind turbines that can produce electricity with very little wind compared to standard turbines. There are two products: Remote Power Unit - a smaller off grid unit used especially for light, with a limited amount of power, and Total Energy Solution, which is larger and can produce much more power. With those wind turbines, we can harness winds from areas that normally are not suitable for wind based electricity production (such as a vast portion of Africa).

We are directly involved in SDG 17 (partnerships), and since electricity is needed for other SDGs we are indirectly involved in them too. We currently have about 12 RPUs in the Caribbean and more elsewhere, and 5 TES in Europe. We are moving at a good pace towards economic profit. We would be honored to have the UN to put a turbine here outside the headquarters. There are five units in Europe of TES.

Gopal Patel, Director of the Bhumi project: This project's goal is to engage the Hindu community to address environmental issues. Bhumi means Mother Earth in Hindi. We also work with multi faith organizations, such as Greenfaith. When approaching the question of how involve people in environmental action, faith can offer networks and can offer wisdom. Research has shown that if you combine all religions, they own 25% of land. They run 50% of all schools, and have the 3rd largest investing block. Declarations of many religions on climate change and climate justice came out recently. In Paris, the Summit of Conscience gathered a hundred poets, religious leaders and artists and asked "Why do you care" about the environment.

We have to understand that people view the world differently and we can't impose our own views on the whole world. Last year we took part in a groundbreaking study. we formed focus groups of 5 major religious traditions and we asked what kind of language speaks to you when it comes to the environment.

Based on the study, we figured out, for example, that in East Asia we shouldn't use the world "justice". This concept comes from a Judeo- Christian worldview and it doesn't speak to people in the East. Instead, we should use "Earth care", "moral challenge", "balance", "action", "personal pledge", "integral ecology". "journey", "wake up" etc.

Amir Dossal: Before we move on to questions from the audience, please tell us in 30 seconds: What will you commit for the implementation SDGs?

Dan Connors and Jim Smith: We are a commercial enterprise but we commit to a public-private partnership. 11 of our used products were donated. 3 are in schools, community colleges. (goal 17)

- Gopal Patel: My commitment is my life. I commit to dedicate myself to the cause. The SDGs aren't new, they're just re-branding. My job is to empower people, and also to just to be a good person.

- Bryan Maygers: My commitment and the commitment we try to embody at Huffpost is to not lose hope. It's very easy to despair after reading a lot of bad news. There are solutions everywhere, It's just a matter of empowering people to feel they can take part in them.

The discussion of the SDG icons and how they were formed was new and interesting. So, was Leslee Udwin's description of her Think Equal curriculum designed to educate the global citizens of tomorrow. Eunhee's panel on STEAM was particularly well-done.

I have heard many favorable comments concerning conference and it has done a great deal to build momentum and support for an international day of education for global citizenship. The quality of the speakers and the organization of the information was of the highest quality. It is because of this very high quality of the presentations that it's so sad that the audience was not larger. I've been told there is a video record, which I hope can be disseminated widely. The presentations deserve to be seen by a very wide audience.

The financial and content support of the World Development Foundation was crucial to the quality of the presentations. The participation of Permanent Representatives and Deputy Permanent Representatives of the Republic of Korea, Canada, and others including small island states gave the conference depth and perspective. High level UN officials from DPI, UNESCO and other parts of the UN system added to the important information provided by business leaders and academics.

The conference was not as expansive as originally designed due to the withdrawal of Ukrainian sponsorship. By the time Ghana stepped forward, we could no longer host workshops or have as expansive a conference as originally designed. Opening by the President of the Cooperative Republic of Guyana

The Conference was officially opened by H.E. Brigadier David Granger, President of the Cooperative Republic of Guyana, who offered his country as the gateway to Latin America, since Guyana is the single English-speaking country in South America. President Granger also reaffirmed March 21 as International Day of Forest, an affirmation that Guyana is serious in becoming a "GREEN STATE."

President Granger informed the meeting that tourism connects countries, markets, peoples, and services throughout the hemisphere. Tourism can contribute to the development of the Americas and to the wellbeing of future generation by becoming more sustainable.

President Granger urged the conference to seek solutions to ensuring that the Americas would be able to catalyze their tourism potential by increasing annual tourist arrivals.

Besides representatives from OAS member states, stakeholders from the private sector and the tourism industry also participated. The aviation sector, travel companies, airlines, the Guyana Tourism Board, and hotels also showcased their products. Copa Airlines Vice President of marketing, Christophe Didier; Kayla Reece of Fly Jamaica; and Ivan Lopez Villalba gave presentations. Suriname Airways was also present at the opening session.

The aviation industry is growing rapidly in Guyana and the main port of entry, the Cheddi Jagan International Airport (CJIA), will complete its first phase of US\$150 million expansion and modernization in 2018. There are also plans to turn the frontier airstrip at Lethem into an international regional airport.



The Eugene Correia International Airport shared its 5, 10 and 15-year development plans at the Conference. In the near future, this airport also plans to extend the runway to accommodate larger aircrafts and private jets. The terminal is currently too small and will have to triple in size to accommodate projected growth for the next two decades.

The WDF-LAC attended as an observer, since the Organization has been keen in promoting the Guiana Shield region as an upcoming and very promising sustainable tourism venture for adventure, Amazonian, forestry and green fanatics. WDF-LAC used its presence in Georgetown to introduce this idea to the Caribbean Tourism Organization, various Governments in mainly Central America, businesses and NGOs based in Georgetown.

Henry Mac Donald of the WDF-LAC also spoke privately with the First Vice-President and Minister for Indigenous Affairs of Guyana, H.E. Sydney Allicock, the Honorable Dominic Gaskin, Minister of Business of Guyana and Ms. Kim Osborne, Executive Secretary for Integral Development of the OAS.

Suriname was officially represented at the Conference by Ms. Liselle Blankendall, Charge d'Affaires a.i. at the Embassy of Suriname in Guyana. It is important to inform that Suriname was invited by Mr. Hugh Riley, CEO and Secretary General of the Caribbean Tourism Organization (CTO) to join the Organization in order to enjoy the benefits and services of the group. Guyana is a member of the CTO.

Main speakers at the conference were, among many others: Honorable Dominic Gaskin M.P., Minister of Business of Guyana; H.E. Nestor Mendez, Assistant Secretary General of the OAS (video); Ms. Kim Osborne, Executive Secretary for Integral development at the OAS; Mr. Donald Sinclair, Director General at the Department of Tourism at the Ministry of Business; Dr. Richard Brown, CARICOM Director of Single Market and Sectoral Programs; Mr. Alejandro Varela, Deputy Regional Director for the Americas, UNWTO; Captain Jagmohan Singh, Vice President of operations at Caribbean Airlines, Ms. Julia Reifer Jones, CEO LIAT; Mr. Christopher Didier, Sales Vice president, COPA Holdings; Mr. Pablo Chalen, Commercial Director, travel Retail Latin America: Mr. Hugh Riley, CEO and Secretary General of the Caribbean Tourism Organization; Dr. David Singh, Director Conservation International Guyana; Ms. Catherine Hughes, Minister of telecommunications of Guyana; Ms. Sandra Howard, Vice Minister of Tourism of Colombia.


WDF, Report 24th OAS Congress of Ministers of Tourism, Georgetown, Guyana





CONNECTING THE GUIANAS THROUGH SUSTAINABLE TOURISM:

The power-point presentation by the Director General of Tourism, Mr. Donald Sinclair focused largely on the development of the Guyana Shield region as a new, unique, green and future international tourism destination. In the presentation entitled "Connecting the Guianas through Sustainable Tourism", the Director General brilliantly expressed the various previous initiatives, taken by all 3 Guianas to develop the region as a potential tourism destination:

- The Guianas Trial (GT) - a Guyana Tourism Private Sector Initiative of 2003;

- The Combined Amazon Tourism Project (CATP) – Initiative of the Suriname Tourism Foundation (2005 – 2007);

- The Amazon Caribbean Tourism Trail (ACTT) – Initiative of the Amazon Cooperation Treaty Organization (ACTO - 2009).

The outcomes of these three initiatives were as follows:

- GT: Guyana and Suriname tourism bodies did not meet to develop and implement concrete plans. The initiative stalled at the official level, however the tour-operators links on the ground, continue;

- CATP: there were meetings held involving operators from Suriname and French Guiana. Brochures where made and published. Changes of officials on the French side slowed down the process and progress was ultimately halted; - ACTT: The initiative involved Guyana, Suriname and the state of Para in Brazil. A destination manual was produced and launched at ITB 2010. There was a clear basis laid for later initiatives for cooperation in tourism.

With respect to Government to Government initiatives he mentioned that Guyana and Suriname drafted a Tourism Accord last year and that the initiative is presently in stages of finalization between both countries.

On the NGO side the Director General mentioned that the World Development Foundation recently launched a Guyana Shield Sustainable Tourism Initiative. The Permanent Mission of Suriname at the United Nations launched the engagement. Both Ambassadors of Guyana and Suriname took the bold step to present that idea at a well-attended Public Private Partnership Conference, organized by Suriname in May 2017 at the United Nations in New York.

With regard to specific points of focus in order to move forward, Mr. Sinclair touched on the following important matters:

- Creation of connected itineraries based upon outstanding natural and cultural attractions;

- Constant monitoring to ensure quality assurance;
- Increasing transportation links;
- Shared product research and information gathering;
- Border port travel facilitation;
- Agreement regarding appropriate standards.

With respect to the future promotion of the Guiana Shield, the Director General highlighted the following key topics:

- More effective use of resources through joint promotional activities – trade fairs, road shows etc.; regard to the future promotion of the Guiana Shield he finally mentioned the following key topics:

- Cooperation in branding of the Guianas product and use of websites, social media and other online campaigns.

<u>The Declaration of Georgetown: Connecting the Americas through</u> <u>Sustainable Tourism (CIDI/TUR-XXIV/RP/doc.3/18).</u>

WE, THE MINISTERS AND HIGH-LEVEL AUTHORITIES OF TOURISM OF THE MEMBER STATES:

- 1. Recognize the importance of continuing to work towards expanding connectivity and increasing sustainable tourism within the countries of the Americas, including through forging alliances or strengthening them where they already exist, among public and private stakeholders.
- 2. Encourage the establishment and strengthening of public-private partnerships among the different actors of the tourist sector that contribute to improving the connectivity of the sub-regions of the Americas and promote the development of sustainable tourism.
- 3. Encourage the competent authorities of other tourism related sectors, such as transportation, security, infrastructure, etc., to analyze and implement, when possible, coordinated policies to achieve optimal development in connectivity and increase sustainable tourism benefits.
- 4. Encourage relevant authorities to adopt air transportation policies that enhance connectivity for the benefit of travelers, shippers and the tourism and business sectors. (Agreed ad referendum of the delegation of Argentina 2/8/2018)
- 5. Request that the General Secretariat collaborates with other regional agencies in undertaking an impact study regarding the impact of the sharing economy on the tourism accommodation sub-sector in Latin America and the Caribbean, in order to address and provide recommendations on, inter alia, the best arrangements that can successfully incorporate the share accommodation alongside the formal accommodation sub-sector.
- 6. Will continue to work so that the development of tourism in the region is conducted within the framework of sustainability, focusing on its three pillars: environmental, sociocultural, and economic.

- 7. Request the authorities of the Congress (TROIKA and CITUR Authorities) to begin planning the formulation of a sustainable community tourism development management model for the Americas, using as a basis the existing national models and initiatives, and taking into account the context of each country, to strengthen the integral development and the growth of the sector in the region.
- 8. Urge the CITUR to support the sharing of best practices on travel and tourism facilitation, including visa facilitation, to promote intra-regional and multi-destination travel among countries of the Americas.
- 9. Instruct the General Secretariat to submit for the consideration of the Authorities of the Congress, at its Planning Meeting to be held no later than July 31, 2018, a work plan based on the guidelines contained in this Declaration and that contribute to the implementation of the commitments of the Medium-Term Strategy to Enhance Tourism Cooperation and Competitiveness in the Americas.
- 10.Request the OAS General Secretariat to work with regional and international organizations and other relevant institutions in identifying adaptation strategies and plans which strengthen resilience, mitigate the impact of natural disasters on the tourism sector, and support tourism business recovery in a disaster's aftermath in OAS member states, with a focus on resource mobilization for the execution of identified initiatives, including, implementation of the actions contained in the Multi-hazard Contingency Planning Manual for the Caribbean Tourism Sector (OAS/CDERA).



Vote of Thanks to the People and Government of Guyana

At the conclusion of the Congress, the Declaration of Georgetown on Connecting the Americas Through Sustainable Tourism was adopted and the Ministers and high Level Authorities of Tourism encouraged the establishment and strengthening of Public Private Partnerships among the different actors of the tourist sector that contribute to improving the connectivity of the sub-regions of the Americas and promote the development of sustainable tourism, and commitment to continue the work so that the development of tourism in the region is conducted within the framework of sustainability focusing on its three pillars: environment, socio-cultural and economic.
